The purpose of this qualitative study is to determine the factors that motivate Hearing Investing Serving (H.I.S.) Years participants to engage in a two year voluntary global service project, their perceived expectations for their overall experience and whether their support systems, coursework and past experiences have prepared them for their extended overseas service trip.

What are the factors for Hearing Investing Serving (H.I.S.) Years participants attending Azusa Pacific University that motivates them to engage in a two-year global service project.

### target sample demographics

Participants in this study will be individuals from Azusa Pacific University who have been accepted into the Hearing Investing Serving (H.I.S.) Years program. There are currently approximately 15 students who meet this qualification. A list of the qualified participants will be provided to the Primary Investigators, Heather Bixby and Erin Lind by Jillian Gilbert who currently oversees the H.I.S. Years program. These students will be contacted during one of their weekly meetings and interviews will be set up through a sign-up sheet and/or email.

No inducement will be offered to students who participate.

If communication can be made, several of the Hearing Investing Serving (H.I.S.) Years participants who have previously matriculated from the university and are currently serving and/or will depart within the year will be interviewed. In the published research these individuals will be noted as a separate group. There are currently approximately 4 students who meet this qualification.

Instruments will not be used in this study. Students will participate in an interview process where they are asked open-ended questions (see attached) and their responses will be noted by the researchers through note taking and voice recording. Each interview will last approximately 60 minutes, and participants will be interviewed in a closed and quiet room on campus to ensure confidentiality and minimal interruptions. Data will also be obtained from participants' applications to the Hearing Investing Serving (H.I.S.) Years program (upon approval from the program director and the participants)

Participants will be interviewed in a closed and quiet room. The field notes and voice recordings will be kept confidential after the completion of the qualitative study.

#### 8. Foreseeable Benefits: What are the potential benefits associated with this project?

The Hearing Investing Serving (H.I.S.) Years program will have research to guide development and future practice within the program. The research can also provide insight into the student populations on campus that should be targeted for recruitment.

We do not see any obvious foreseeable risks. However, if a question asked by the interviewers elicits some distressing experience and the student appears to be stressed, the interview will be terminated and the student will be referred to the Counseling Center.

Students will be given an Informed Consent Form (Form E) customized for this research project to read and sign. This form will be described to them before the interview begins, and the researchers will notify them that their participation or non-participation in the study will not be known by the Hearing Investing Serving (H.I.S.) Years staff. When the students come to the interview, after the Informed Consent Form is explained, along with the research project, they will be given an opportunity to ask questions and then if they agree to proceed, will be asked to sign a hard copy of the Informed Consent Form. Participants will receive a copy of the consent form and a signed copy will be retained by the researchers.

#### 11. Data Analysis: Please include your strategy for data analysis.

Students' interviews will be recorded via field notes and voice recording. In the qualitative tradition, open, axial and selective coding will be used to analyze the field notes for themes. The participants' applications to the program will also be reviewed and coded for themes that are influential to this qualitative study. The notes from the interviews will be kept in a locked drawer and will be kept confidential after the research is completed.

# 12. <u>Dissemination</u>: Please describe your plan for dissemination of your data including targeted conferences and publications.

The results of this research project will be disseminated to Dr. Sharyn Slavin Miller, Matthew Browning, George Bache, and Jillian Gilbert. The results will also be posted on a website that serves as a capstone project for our Master of Education in Student Affairs degree. There is potential for this research to be presented at the Associations of Christians in Student Development national conference as well as at the Go Summit. Publication of this research, in the *Journal of College Student Development, Growth: The Journal of Association of Christians in Student Development, and/or Christian Scholar's Review* and other applicable Christian student development resources will be pursued by the researchers.
